Subject: LRALC and NALC affiliation fees 2020/21

Dear member council,

The LRALC Board of Director's at their meeting on Monday 9th December 2019 considered the affiliation fees for 2020/21. You will be aware that the LRALC affiliation fee is made up of two elements; a "per elector" fee which has been subject to small annual increases for a number of years and a banded flat fee which has not increased since 2011.

The Board resolved to increase the banded flat fee element of the LRALC affiliation fee for 2020/21 and, as such, the new fees are detailed below for information. There will be no increase to the "per elector" fee element of the LRALC subscriptions.

Electorate	New flat fee
Electorate 1-1000	£72.50 (an increase of £7.50)
Electorate 1001-2000	£100.00 (an increase of £10)
Electorate 2001-6000	£115.00 (an increase of £20)
Electorate 6001 to end	£155.00 (an increase of £20)

For information, NALC's AGM in October resolved to increase its fee for 2020/21, which is also calculated on a "per elector" basis, to 7.20 pence per elector with a cap of £1,840 for larger councils.

We hope this information will assist in your budget setting preparations.
